4. The Releasing Company will be liable for all charges incurred on the connections up to the date Vodafone actions the change of ownership and confirms with both parties that it has been affected. These charges will show on the next invoice issued to the Releasing Company and will include any pro-rata charges.

The Gaining Company will be responsible for and, if a number is terminated prior to the expiry of the applicable Connection term, pay any Early Termination Charges applicable to that number.
- I understand that if the numbers currently have rate plans, products, services or bundles that the Gaining Company is not entitled to then Vodafone will modify and/or remove them.
- Notification will be provided to me on completion of the change of ownership and I understand that any changes I wish to make after receiving this notification will be subject to Vodafone terms and conditions and may incur charges.
